## **SET UP**

You may pull your vehicles to the back doors to unload your equipment. However please be mindful of others who wish to do the same by unloading and quickly removing your vehicle. Vendor vehicles must be moved to the back of the lot no later than 45 minutes prior to the start of the event. All vendors must be present and booths set up 60 minutes prior to the start of the event. If your booth is not setup sixty minutes prior to the start of the event, you forfeit your right to receive the bride contact list and may jeopardize participation in any further Say "I Do" Wedding Shows.

Booth space is limited and is awarded on a first come first serve basis.

**Booth placement:** Say "I Do" wedding show maintains sole discretion, and reserves the right to assign and/or reassign and/or change the location of all spaces or booths at any time.

## **Removal and Clean up**

All vendors are responsible for clean up and removal of items in their vendor space. Anything left behind will be discarded or property of Say "I do" wedding show. If your space is not the way you found it, you will be charged a clean -up fee of \$100. Any damage to The Blankenbaker property is the vendor responsibility at the value of the assessed damage.

## **ATTENTION CATERERS**

All food must be precooked and ready to serve- there are no ovens available on site. Any vendors serving food will need to present their certificate of insurance and are responsible for the food liability.

## **Additional Vendor Terms and Conditions:**

1) NO booth sharing allowed. Only the Vendor listed above is permitted to display its products/services. Vendors shall not allow other businesses, organizations and/or individuals to display products/services in their booth.

2) We will supply you with a list of brides who registered and/or attended this show. Vendor agrees to use the list of names from this show only for the use of the Vendor signed above and not to share such information with any third party. (Warning – we plant bogus names in our list in order to verify this condition). Failure to follow this condition will jeopardize any future participation in Say "I Do" Wedding Shows.

3) Say "I Do" Wedding Show, reserves the right to cancel this show in the event of inclement weather or for any other reason in its sole discretion. In the event of such a cancellation, every effort will be made to reschedule this show to another date. No refunds will be given in the event of cancellation.

4) Say "I Do" Wedding Show makes no guaranty or warranty as to Vendor's performance and/or sales revenues generated from the event

5) The venue will be providing 60" round or 8' rectangular tables and floor length tablecloths. Due to limited amount of space, backdrops, pipes and drapes are not allowed unless you purchase two spaces.
